APPLICATION FOR MARRIAGE CEREMONY

Those who wish ISGVF Imam to preside over their Marriage Ceremony in accordance with the teachings of Islam, must submit the following information at least two weeks before the scheduled ceremony. The bride and groom must have a valid civil marriage license and the license must be submitted to ISGVF before the scheduled ceremony. Otherwise ISGVF reserves the right to refuse to conduct the marriage. The groom must be a Muslim, and the bride must either be a Muslim or from the People of the book. Additionally, if the bride and groom are unknown to the Imam, he may request a letter of reference from an ISGVF member or a member from the community. The Imam must be permitted to interview the bride and groom prior to the ceremony. Alcohol, drugs or any other prohibited (Haram) items or food are not permitted at the site of the marriage. This application must be signed by either the bride or groom or one of their parents indicating compliance with the above conditions. Please note that a fee of \$500 is payable to ISGVF for the Imam to preside over the ceremony. This fee should be paid with the application. All applications are tentative pending ISGVF approval. Applications will be considered confirmed only once explicit ISGVF approval has been received. ISGVF discourages any announcement of proposed ceremony prior to application approval confirmation.
